Bay City will hold a public hearing at 5:30PM on January 3, 2022, at 1901 Fifth Street, Bay City, TX 77414, regarding the submission of an application to the Texas Department of Housing and Community Affairs for a Community Development Block Grant CARES Act (CDBG-CV) grant for the Texas Community Resiliency Program. Social distancing and masks are required if attending in person. The purpose of this meeting is to allow citizens an opportunity to discuss the citizen participation plan, the development of local public facilities and improvement needs and public service needs, the amount of CDBG-CV funding available, all eligible CDBG-CV activities, and the use of past CDBG-CV funds. The City encourages citizens to participate in the development of this CDBG-CV application and to make their views known at this public hearing. Citizens unable to attend this meeting may submit their views and proposals to the City Secretary.
